GRADE IV (DASS) (POST CODE 61/2015)
IN SERVICES DEPARTMENT

1. The DSSSB vide Result Notice No. 690 dated 16/07/2018, Result Notice No. 740 dated 16/11/2018, Result Notice No. 783 dated 17/05/2019 and Result Notice No. 789 dated 29/05/2019 has provisionally selected 895, 17, 27 and 43 candidates respectively for the Post of Grade IV (DASS) in the Services Department under Post Code 61/2015 against the revised vacancies on the basis of the One Tier Written Examination held on 17/09/2017 and the skill test of Shortlisted candidates conducted with effect from 03/01/2018 to 14/01/2018 and 08/04/2018 (for VH category candidates).

2. User Department, i.e., Services Department, Govt. of NCT of Delhi has returned 47 Dossiers (UR-36, OBC-01, SC-07, ST-02 and VH-01) on the grounds that candidates have not responded/Joined/ not found suitable to the post of Grade IV (DASS)/LDC. Further, 34 candidates (UR-29, OBC-02, SC-02 and ST-01) had also resigned from the Post of Grade IV (DASS)/LDC. The dossiers/resignation cases have been returned before the expiry of waitlist panel. Hence the Board is declaring the result of Panel/Waitlisted Candidates as per their merit, as per details below:-

The candidates having roll number 15448778, 15451640, 15437750, 15427258, 15424965, 15428438, 15416431, 15403530, 15423639, 15409120, 15414919, 15452117, 15448262, 15423129, 15449144, 15425612, 15446952, 15445952 and 15421225 who were earlier selected in OBC category have now been shifted to the UR Category as per merit list. The vacancy created vide shifting has been filled by the candidates from the waitlist panel of OBC Category.

4. The candidates having roll number 15447755, 15422415, 15456425, 15405843, 15428841 and 15450221 who were earlier selected in SC category have now been shifted to the UR Category as per merit list. The vacancy created vide shifting has been filled by the candidates from the waitlist panel of SC Category.

5. Candidature of 01 candidate having roll no. 15423213 is still withheld in UR Category in view of FIR filed against him during skill test.

6. Candidature of 01 candidate having roll no. 15430666 is hereby kept pending for seeking clarification from the Services Department regarding admissibility of OBC Category plus EXSM category age relaxations.

7. Candidature of 01 candidate having roll no. 15439805 is hereby kept pending as the candidate has furnished the OBC Certificate issued after cut off date.

8. The Selection of the above 76 candidates (UR-40, OBC-21, SC-15) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

9. It is stated that the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above

candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

10. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.

11. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms *vis-à-vis* the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

12. There is no candidate in Select Panel in ST & VH Category as such no candidate can be nominated against returned dossier in this Category.

13. The result is subject to the outcome of the court cases pending in various courts related to this post.

14. The Wait List panel of the candidates was valid up to 15/07/2019.

15. The category wise marks scored by the last candidate provisionally nominated are as under:-

16. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
