RESULT NOTICE NO. 775

WARDER MALE (POST CODE-37/13)
IN DELHI PRISONS DEPARTEMNT

1. The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the post of Warder (Male) in Delhi Prisons Department.
2. The Board had conducted the written examination on 02.03.2014 for the post of Warder (Male) under postcode 37/13. On the basis of the written examination the candidates were shortlisted to appear for PET, which was qualifying in nature. After conducting the Physical Endurance test (PET-I, PET-II & PET-III) in respect of shortlisted candidates from 16.03.2015 to 22.03.2015 and also from 01.07.2016 to 09.07.2016; on 06.05.2017 and from 12.02.2018 to 14.02.2018, 461 candidates who qualified the PET were nominated to the post of Warder (Male) under post code 37/13 vide result notice No. 357 dated 29.12.15 and subsequent result notice No. 381 dated 07.03.2016, result notice No. 382 dated 13.04.2016, result notice No. 471 dated 15.2.17, result notice No. 523 dated 27.06.2017 and result notice No. 683 dated 09.08.2018.
3. The DSSSB vide its result notice 706 dated 23.8.2018 had shortlisted 1391 candidates for appearing in the Physical Endurance Test (PET-IV) for the post of Warder in Delhi Prisons Department under postcode 37/13 for selection to candidates against the unfilled vacancies.
4. The PET-IV was conducted from 04.10.2018 to 11.10.2018, wherein out of 1391 shortlisted candidates only 490 appeared for PET. Further from the 490 present candidates only 59 could qualify the PET.
5. The candidature of candidates having roll number 13007595, 13029611 and 13049618 is still withheld for further examination.
6. As the e-dossier link of 06 candidates having roll number 13008112, 13013479, 13041169, 13019749, 13011156 and 13044479 could not be opened, these candidates were directed vide notice 19.12.2018 to furnish the requisite documents on **e-mail: helpdesk-dsssb@nic.in**. As the candidates having roll number 13008112, 13013479, 13041169 and 13011156 have not

responded to the notice dated 19.12.2018 as such their candidature is hereby cancelled.

7. The candidature of candidate having roll number 13031256 was pending in OBC category, however now it has been came to notice that applicant has been issued the OBC(Migrant) certificate No. 9050000034061 dated 20.11.2017 on the basis of his father's OBC certificate dated 11.4.16 issued from UP state, as such the candidate being not eligible for grant of OBC reservation in Delhi, as such his candidature is hereby cancelled.

8. Ld CAT vide its interim order dated 07.04.2015 in OA No1294/15 in the matter of Varun Sharma vs GNCTD has directed to keep one post under as pending, accordingly one post of UR category is kept as pending.

9. After preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement on qualifying the PET, the following candidates are provisionally selected to the post of Warder(Male) subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet etc.) to be checked by the User Department which would render candidate ineligible for recruitment as per the requirement of the RRs:

14. Candidatures of following **06** OBC candidates having 13041779, 13030587, 13009051, 13045066, 13006770 and 13040578 are pending as the candidates have furnished the OBC certificates after cut off date.

15. The selection of the above **41** Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. **Further the user department shall arrange for checking of defect or deformity (including bow legged, knocked knees, flat feet etc.) of the candidates as per the requirement of the RRs, which has not been done during PET-III.**

16. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.

17. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

18. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

19. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

20. The selection of the candidates are subject to the outcome of the court order in the matter of Vinay Mann Vs GNCTD in OA number 2284/16 or other pending court case, if any.

21. The result process for the above Post Code stands closed in all respect except 06 pending candidates and 01 court case candidate. Since, no qualified candidate is available in the SC/ST Category, hence, no waiting list has been prepared for SC/ST Category. Further validity for waitlist panel of the candidates under UR and OBC Category will be 08.07.2019.

22. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

23. **While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.**
