



The candidates will be medically examined in 'Safety Category' for the post of ASTE (Gr. B) by concerned CMS/MS of the Divisions/Units. Candidates working in HQ will be medically examined by CMS/SEE. SPO/Rectt/HJP will issue Medical Memo for concerned HQ staff. Concerned Personnel Officer of the Division/Units will issue the Medical Memo for the candidates of Divisions/Units.
