RESULT

On the basis of Recruitment test for the Posts of **Assistant Professor (College cadre) in Higher Education department in the subject of English** conducted by the Haryana Public Service Commission on 12.06.2019, the candidates, three times the number of vacancies alongwith bracketed candidates, if any, bearing the following Roll Nos. have been declared qualified for Viva-Voce provisionally, subject to the fulfillment of all eligibility conditions. 
