### **Final Result (Remaining) for the post of MPHWH (FEMALE) For Health Services and ESI Health Care, Haryana Against Advt. No. 1/2015, Cat No. 09, with Corrigendum Dated 01.07.2015 and 24.10.2016**

Chief Secretary to Government of Haryana vide Memo No. 22/149/2015-1 GS-III dated 5th March, 2019, has informed that the State Government has decided that in respect of all advertisements where result of SBC has been put on hold due to Court Orders, the Haryana Staff Selection Commission shall treat the SBC posts to be under the Unreserved/General Category.

Therefore now, in continuation of earlier notice dated 08.03.2018 and on the basis of Scrutiny of Documents and Interview Viva-Voce , for the posts of MPHWH (Female), Cat. No. 09, Advt. No.01/2015 of School Education Department Haryana, Commission has finalized and declared the result. The result has been shown roll No. wise and category wise. The marks secured by the last selected candidate in each category have been shown in brackets.
