On the basis of the results of the Jammu & Kashmir Combined Competitive (Mains) Examination, 2018, held by the J&K Public Service Commission from 22.07.2019 to 29.07.2019, the candidates with Roll Numbers as per **Annexure-A** to this notification have qualified for Personality Test for selection to the J&K Combined Competitive Services i.e. Junior Scale of J&K Administrative Service, J&K Police(G) Service and J&K Accounts (G) Service.

Candidature of these candidates is provisional subject to their being found eligible in all respects. The candidates will be required to produce the original certificates in support of their claims pertaining to age, educational qualifications, category and disability, if any, etc. at the time of their Personality Test. No paper Summon Letters will be issued for the Personality Test/Interview by the Commission. The date and time of Personality Test will not be intimated to the qualified candidates individually.

No request for change in the date and time of the Personality Test intimated to the candidates will be entertained.




