

They are advised to report to General Manager (P), RCF/KXH office on 23.07.2019 at 10,00 hrs. along with Medical fitness Certificate duly issued by Government authorized doctor(Gaz.) not below the rank of Asstt. Surgeon of Central/State Hospital.

It is mentioned that this information has already been sent to concerned candidates through SMS and e-mail on their respective mobile nos. and e-mail IDs on 18.07.2019.

Candidates must understand clearly that mere inclusion of their name in the panel dose not mean that they are selected for training. Their selection as Act Apprentices is subject to passing/satisfy the minimum standards of physical fitness (as per medical standards) as prescribed in the aforesaid Act and Apprenticeship Rules 1992 as amended from time to time. Candidates must bring original documents/ID proof at the time of reporting.
